I am the Chair of Pediatrics at the University of Colorado and Pediatrician-in-Chief and L. Joseph Butterfield Chair in Pediatrics at Children's Hospital Colorado. I have been a member of the American Pediatric Society for over two decades and served on the Nominating Committee in 2015-2016. I have been a member of the Council since 2017. During my time on the Council, I have participated in the strategic planning process designed to develop new ways for the APS to provide value to members. This strategic planning process focused on diversity and inclusion, advocacy for child health, later stage career development issues, and how to leverage the expertise of the APS membership across these domains.

I see tremendous potential for the APS to lead the field of academic pediatrics during a time of uncertainty and rapid change. The work done in the past year on diversity, equity, and inclusion is vital, both for the APS as an organization and for the field of Pediatrics. We need to make sure that our criteria for membership reflect our desire to have pediatric leaders from a wide range of

backgrounds and experiences. We also need to work on opportunities for members to be active in the APS and make contributions to the organization.

This is a time when advocacy for issues related to the health of children and the opportunity for academic pediatrics to support children's health via clinical programs, research, and education is critical. The APS must work as an organization to focus on advocacy topics of most importance to our members and then work with other pediatric organizations to ensure that our advocacy voice is heard, and that appropriate legislative and policy changes are implemented.

The strength of APS is in our membership. APS must work simultaneously to support our members at more senior career stages and to leverage their incredible expertise across the entire field of Pediatrics. The American Pediatric Society should be the strongest and most active voice in all pediatric health issues of the day, including funding for research, immigration, health care finance, work force distribution and training the next generation of pediatric leaders.

As President of the APS, I will commit to serving the needs of the Society and its members as we work together to solve the problems facing academic pediatrics and the health of children.
