## **Areas of Research Interest**

I am an academic general pediatrician with a portfolio of scholarship focused on health equity, social determinants of health, and health policy. Throughout my fifteen years as academic faculty, I have impacted child health as a researcher and advocate. My early career focused on identifying contextual factors influencing both health care utilization and retention in care among children with sickle cell disease. This initial scope of research informed subsequent development of behavioral interventions and care delivery models to improve retention in care through addressing social determinants of health. My research has been funded by the National Institutes of Health, Patient-Centered Outcomes Research Institute (PCORI), Agency for Healthcare Research and Quality, and Health Resources and Services Administration. I serve as a Chair for the Addressing Disparities Study Section for PCORI, have been a standing member of the Mentored Patient-Oriented Research Study Section for NHLBI. and acted as an ad hoc reviewer for numerous grant review panels. I have published my work in top scientific and sub-specialty journals. I have served as a guest editor for journal supplements on sickle cell disease (American Journal of Preventive Medicine) and pediatric health disparities (Pediatric Annals). I have been on the Editorial Board for Pediatric Blood and Cancer and currently serve as an Associate Editor for Academic Pediatrics. With a commitment to develop the next generation of health equity researchers, I serve as Associate Director for the Center of Excellence in Health Equity, Training and Research at Baylor College of Medicine. My research endeavors have been complemented by policy efforts to promote screening and addressing of social determinants within health care and managed care organizations. I created and lead the Center for Child Health Policy and Advocacy at Texas Children's Hospital. I have served as an appointee on the Health Disparities Task Force of Texas and subsequently received a Meritorious Service Award from the Texas Health and Human Services Commission.
